

## CALL FOR EVIDENCE    **Race on the Agenda**

### **DCSF Consultation on the Children, Young People and Families Grant Programme to Third Sector Organisations**

#### **Introduction**

On the 29<sup>th</sup> June 2009 the Department for Children, Schools and Families (DCSF) put out a consultation to look at how they could improve their Children, Young People and Families (CYPF) Grants Programme. They want to know whether the programme meets the needs of the third sector and what changes they can make to better support organisations.

**ROTA** will be sending a response to this consultation. Before we do this we are sending this **CALL FOR EVIDENCE** to organisations currently working with Black, Asian and Minority Ethnic (BAME) children, young people and families. We will use this evidence, along with our in-house expertise, to produce:

- 1) A template response for smaller organisations to add-to and use to send their own response to the DCSF
- 2) A BAME response from **ROTA** to be sent to the DCSF

**ROTA**'s template response will be sent to organisations on Monday 21<sup>st</sup> September – this gives two weeks for organisations to use it and send their own response to DCSF (the final deadline for DCSF is 5<sup>th</sup> October).

This document summarises the consultation and puts forward certain questions in relation to it. We will use your views to inform the ROTA response to the DCSF questions.

We have also attached a summary of the DCSF Third Sector Strategy (Annex A) which was published in July 2009. This illustrates the bigger picture within which the CYPF fund would operate and is therefore useful for respondents to consider alongside the consultation document. ## **The Consultation**

The CYPF grant is a national grant programme aimed at improving outcomes for children, young people and families. The results of this consultation will shape the next round of CYPF funding and will be published on the DCSF website in January 2010.

DCSF feels that this grants programme allows flexibility and a space for creating ideas to meet new need. However, the current process could be clearer and more open; the DCSF would like a new approach to be as straight forward as possible, with a process that focuses on how and where the third sector can best contribute to DCSF's overall plan. During the last round they also received too many applications that did not meet the DCSF plan or criteria, therefore a lot of applications were turned down. This time round they want to be clearer from the start, and believe that this will mean they receive less applications, and that those who do apply will have greater chance of success. Furthermore, they would like funding to support the third sector's ability to engage with national policy and the department.

In order to achieve the above, the department want to be clear about the *purpose* of the funding programme. The consultation document proposes two generic purposes of the programme:

### **Strategic Funding**

For organisations that can:

- Provide 'voice' for the third sector at a national level
- Act as a bridge between DCSF and the third sector
- Provide leadership for the sector
- Influence national policy through expertise or experience
- Work with the DCSF to develop policy initiatives
- Work in partnership to build capacity for the sector
- Support local organisations
- Develop a service which delivers a DCSF priority
- Promote and share best practice

### **Innovative Funding**

For bids that have identified a need and propose a service that compliments what is already been provided locally. These projects should:

- use a *new* approach to address a DCSF priority and share the outcomes of this across the sector
- test how effective the project is by repeating it in other areas
- encourage local services to develop work similar to this

4. Asides from the CYPF grant and other DCSF funding, is there any other non-financial support or information from the DCSF that you would find helpful?
5. Are there any examples of good practice from other funders or Government department grant schemes that DCSF could learn from?
6. Apart from what you have already stated in other answers, are there any other ways that the CYPF grant could support children, young people and families better?
7. Apart from the CYPF grant, what else could DCSF do to improve its relationship with the third sector?
